#### D. Hail Damage Repair Bids

Steve Adams spoke to the Board about several concerns he has with missing items from the adjustors report. He would be willing to work with the adjustor on evaluating these items.

Tim Douglas from DV Douglas presented an extensive picture portfolio of damages and maintenance concerns on the school building roofs. He would advise doing a core sample to see the underlying condition of the roof.

The Board would like DV Douglas to do the core sample and then proceed with making a decision based upon these findings concerning the school building roofs. Diamond did present a bid for just repairing what the insurance would pay for. DV Douglas declined to bid at this time until further examination is done, to hopefully prevent further damage and leaks.
